Other Fees & Disclosures:Late Payment Fee:

\$20.00 or the amount of the required minimum payment, whichever is less, if you are 30 or more days late in making a payment.

Annual Fee - Visa New Beginning:

\$12.00.

Returned Payment Fee:

\$15.00 or the amount of the required minimum payment, whichever is less.
